# On Hadamard composition of Gelfond-Leont'ev derivatives of entire and analytic functions in the unit disk

#### Abstract

For an entire function and an analytic in the unit disk function the growth of the Hadamard composition of their Gelfond-Leont'ev derivatives is investigated in terms of generalized orders. A relationship between the behaviors of the maximal terms of Hadamard composition of GelfondLeont'ev derivatives and of the Gelfond-Leont'ev derivative of Hadamard composition is established.


Key words and phrases: analytic function, Hadamard composition, Gelfond-Leont'ev derivative, maximal term.

## Introduction

For power series

$$
\begin{equation*}
f(z)=\sum_{k=0}^{\infty} f_{k} z^{k}, \quad g(z)=\sum_{k=0}^{\infty} g_{k} z^{k} \tag{1}
\end{equation*}
$$

with the convergence radii $R[f]$ and $R[g]$, the series $(f * g)(z)=\sum_{k=0}^{\infty} f_{k} g_{k} z^{k}$ is called the Hadamard composition. It is well known $[1,2]$, that $R[f * g] \geq R[f] R[g]$.

Obtained by J. Hadamard properties of this composition have the applications [2,3] in the theory of the analytic continuation of the functions represented by power series. We remark also, that singular points of the Hadamard composition are investigated in the article [4].

For $0 \leq r<R[f]$, let $M(r, f)=\max \{|f(z)|:|z|=r\}, \mu(r, f)=\max \left\{\left|f_{k}\right| r^{k}: k \geq 0\right\}$ be the maximal term and $v(r, f)=\max \left\{k:\left|f_{k}\right| r^{k}=\mu(r, f)\right\}$ be the central index of the power expansion of $f$.

For a power series of the form (1) with the convergence radius $R[f] \in[0,+\infty]$ and a power series $l(z)=\sum_{k=0}^{\infty} l_{k} z^{k}$ with the convergence radius $R[l] \in[0,+\infty]$ and coefficients $l_{k}>0$ for all $k \geq 0$ the power series

D_{l}^{(n)} f(z)=\sum_{k=0}^{\infty} \frac{l_{k}}{l_{k+n}} f_{k+n} z^{k}
$$

is called [5] Gelfond-Leont'ev derivative of $n$-th order. If $l(z)=e^{z}$ then $D_{l}^{(n)} f(z)=f^{(n)}(z)$ is the usual derivative of $n$-th order. The properties of Hadamard compositions of GelfondLeont'ev derivatives of analytic functions $f$ and $g$ in cases when either $R[f]=R[g]=+\infty$
or $R[f]=R[g]=1$ are investigated in [6]. For example, for entire functions $f$ and $g$ it is proved [6], that if

0<\varliminf_{k \rightarrow \infty} \frac{l_{k}}{(k+1) l_{k+1}} \leq \varlimsup_{k \rightarrow \infty} \frac{l_{k}}{(k+1) l_{k+1}}<+\infty \tag{2}
\end{equation*}
$$

then

$$
\varlimsup_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \frac{\mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=n \varrho[f * g]
$$

and

$$
\varliminf_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \frac{\mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=n \lambda[f * g]
$$

where $\varrho[f]$ is the order and $\lambda[f]$ is the lower order of the function $f$.
If $R[f]=R[g]=R[f * g]=1$ and (2) holds, then [6]

$$
n \varrho^{(1)}[f * g] \leq \varlimsup_{r \uparrow 1} \frac{1}{-\ln (1-r)} \ln ^{+} \frac{\mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)} \leq n\left(\varrho^{(1)}[f * g]+1\right)
$$

and

$$
n \lambda^{(1)}[f * g] \leq \frac{\lim }{r \uparrow 1} \frac{1}{-\ln (1-r)} \ln +\frac{\mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)} \leq n\left(\lambda^{(1)}[f * g]+1\right)
$$

where $\varrho^{(1)}[f]$ is the order and $\lambda^{(1)}[f]$ is the lower order of the analytic function $f$ in the unit disk.

The question about the similar properties of the Hadamard composition naturally arises for the case $R[f] \neq R[g]$. Here, we restrict ourselves to the case $R[f]=+\infty$ and $R[g]=1$. We will conduct researches in terms of generalized orders.

## 1 Analyticity and growth

Since $R[f]=+\infty, R[g]=1$ and $R[f * g] \geq R[f] R[g]$, we have $R[f * g]=+\infty$. In [6], it is proved that for an arbitrary series of the form (1) the equalities $R[f]=+\infty$ and $R\left[D_{l}^{(n)} f\right]=+\infty$ are equivalent if and only if

\begin{equation*}
0<q=\varliminf_{k \rightarrow \infty} \sqrt[k]{l_{k} / l_{k+1}} \leq \varlimsup_{k \rightarrow \infty} \sqrt[k]{l_{k} / l_{k+1}}=Q<+\infty \tag{3}
\end{equation*}
$$

Hence, it follows that $R\left[D_{l}^{(n)}(f * g)\right]=+\infty$ for each $n \geq 0$. Finally, if (3) holds, then $R\left[D_{l}^{(n)} f * D_{l}^{(m)} g\right]=+\infty$ for each $n \geq 0$ and $m \geq 0$. Indeed,

\frac{1}{R\left[D_{l}^{(n)} f * D_{l}^{(m)} g\right]}=\varlimsup_{k \rightarrow \infty} \sqrt[k]{\frac{l_{k}}{l_{k+n}}\left|f_{k+n}\right| \frac{l_{k}}{l_{k+m}}\left|g_{k+m}\right|} \leq Q^{n+m} \varlimsup_{k \rightarrow \infty} \sqrt[k]{\left|f_{k+n}\right|} \varlimsup_{k \rightarrow \infty} \sqrt[k]{\left|g_{k+m}\right|}=0
$$

As in [7], let $L$ be a class of continuous nonnegative on $(-\infty,+\infty)$ functions $\alpha$ such that $\alpha(x)=\alpha\left(x_{0}\right) \geq 0$ for $x \leq x_{0}$ and $\alpha(x) \uparrow+\infty$ as $x_{0} \leq x \rightarrow+\infty$. We say that $\alpha \in L^{0}$, if $\alpha \in L$ and $\alpha((1+o(1)) x)=(1+o(1)) \alpha(x)$ as $x \rightarrow+\infty$. Finally, $\alpha \in L_{s i}$, if $\alpha \in L$ and $\alpha(c x)=(1+o(1)) \alpha(x)$ as $x \rightarrow+\infty$ for each fixed $c \in(0,+\infty)$, i.e. $\alpha$ is a slowly increasing function. Clearly, $L_{s i} \subset L^{0}$.

For $\alpha \in L, \beta \in L$ and an entire transcendental function (1) the quantities

\varrho_{\alpha, \beta}[f]:=\varrho_{\alpha, \beta}[\ln M, f]=\varlimsup_{r \rightarrow+\infty} \frac{\alpha(\ln M(r, f))}{\beta(\ln r)}
$$

and

$$
\lambda_{\alpha, \beta}[f]:=\lambda_{\alpha, \beta}[\ln M, f]=\varliminf_{r \rightarrow+\infty} \frac{\alpha(\ln M(r, f))}{\beta(\ln r)}
$$

are called the generalized order and the lower generalized order, respectively. If here we substitute $\ln \mu(r, f)$ or $v(r, f)$ instead of $\ln M(r, f)$, then we obtain the definitions of the quantities $\varrho_{\alpha, \beta}[\ln \mu, f], \lambda_{\alpha, \beta}[\ln \mu, f]$ and $\varrho_{\alpha, \beta}[v, f], \lambda_{\alpha, \beta}[v, f]$, respectively.
Lemma 1. Let $\alpha \in L_{s i}, \beta \in L^{0}$ and $\frac{d \beta^{-1}(c \alpha(x))}{d \ln x}=O(1)$ as $x \rightarrow+\infty$ for each $c \in(0,+\infty)$. Then

\begin{equation*}
\varrho_{\alpha, \beta}[f]=\varlimsup_{k \rightarrow \infty} \frac{\alpha(k)}{\beta\left(\frac{1}{k} \ln \frac{1}{\left|f_{k}\right|}\right)} . \tag{4}
\end{equation*}
$$

If, moreover, $\left|f_{k} / f_{k+1}\right| \nearrow+\infty$ as $k_{0} \leq k \rightarrow \infty$, then

$$
\begin{equation*}
\lambda_{\alpha, \beta}[f]=\varliminf_{k \rightarrow \infty} \frac{\alpha(k)}{\beta\left(\frac{1}{k} \ln \frac{1}{\left|f_{k}\right|}\right)} \tag{5}
\end{equation*}
$$

Formula (4) was proved in [7], and formula (5) follows from the corresponding formula for entire Dirichlet series proved in [8].

Proposition 1. Let the functions $\alpha$ and $\beta$ satisfy the conditions of Lemma 1 and (3) holds. Then $\varrho_{\alpha, \beta}[f * g] \leq \varrho_{\alpha, \beta}[f]$ and under condition

$$
\begin{equation*}
\varliminf_{k \rightarrow \infty} \sqrt[k]{\left|g_{k}\right|}=h>0 \tag{6}
\end{equation*}
$$

the equality $\varrho_{\alpha, \beta}[f * g]=\varrho_{\alpha, \beta}[f]$ holds.
If, moreover, $\left|f_{k}\right| /\left|f_{k+1}\right| \nearrow+\infty$ and $\left|g_{k} / g_{k+1}\right| \nearrow 1$ as $k_{0} \leq k \rightarrow \infty$, then $\lambda_{\alpha, \beta}[f * g] \leq \lambda_{\alpha, \beta}[f]$ and under condition (6) the equality $\lambda_{\alpha, \beta}[f * g]=\lambda_{\alpha, \beta}[f]$ holds.
Proof. Since $\varlimsup_{k \rightarrow \infty} \sqrt[k]{\left|g_{k}\right|}=1 / R[g]=1$, for every $h>1$ and all $k \geq k_{0}(h)$ we have $\sqrt[k]{\left|g_{k}\right|} \leq h$, that is $(1 / k) \ln \left(1 /\left|g_{k}\right|\right) \geq-\ln h$. Therefore, since $\beta(x+O(1))=(1+o(1)) \beta(x)$ as $x \rightarrow+\infty$, by Lemma 1 we get

$$
\begin{aligned}
\frac{1}{\varrho_{\alpha, \beta}[f * g]} & =\varliminf_{k \rightarrow \infty} \frac{1}{\alpha(k)} \beta\left(\frac{1}{k} \ln \frac{1}{\left|f_{k} g_{k}\right|}\right) \\
& =\varliminf_{k \rightarrow \infty} \frac{1}{\alpha(k)} \beta\left(\frac{1}{k} \ln \frac{1}{\left|f_{k}\right|}+\frac{1}{k} \ln \frac{1}{\left|g_{k}\right|}\right) \geq \frac{\lim }{k \rightarrow \infty} \frac{1}{\alpha(k)} \beta\left(\frac{1}{k} \ln \frac{1}{\left|f_{k}\right|}-\ln h\right)=\frac{1}{\varrho_{\alpha, \beta}[f]},
\end{aligned}
$$

i.e. $\varrho_{\alpha, \beta}[f * g] \leq \varrho_{\alpha, \beta}[f]$. If (6) holds, then as above we have
$\frac{1}{\varrho_{\alpha, \beta}[f * g]}=\varliminf_{k \rightarrow \infty} \frac{1}{\alpha(k)} \beta\left(\frac{1}{k} \ln \frac{1}{\left|f_{k}\right|}+\frac{1}{k} \ln \frac{1}{\left|g_{k}\right|}\right) \leq \varliminf_{k \rightarrow \infty} \frac{1}{\alpha(k)} \beta\left(\frac{1}{k} \ln \frac{1}{\left|f_{k}\right|}-\ln (h / 2)\right)=\frac{1}{\varrho_{\alpha, \beta}[f]}$, i.e. $\varrho_{\alpha, \beta}[f * g] \geq \varrho_{\alpha, \beta}[f]$ and, thus, $\varrho_{\alpha, \beta}[f * g]=\varrho_{\alpha, \beta}[f]$.

The inequality $\lambda_{\alpha, \beta}[f * g] \leq \lambda_{\alpha, \beta}[f]$ and the equality $\lambda_{\alpha, \beta}[f * g]=\lambda_{\alpha, \beta}[f]$ can be proved similarly.

Remark 1. In general, the equality $\varrho_{\alpha, \beta}[f * g]=\varrho_{\alpha, \beta}[f]$ may not hold. Indeed, let for example

$$
f(z)=\sum_{n=0}^{\infty} \exp \left\{-2 n \beta^{-1}(\alpha(2 n))\right\} z^{2 n} \quad \text { and } \quad g(z)=\sum_{n=0}^{\infty} z^{2 n+1}
$$

Then by Lemma 1 we have $\varrho_{\alpha, \beta}[f * g]=0<1=\varrho_{\alpha, \beta}[f]$.
Lemma 2. If $\alpha \in L_{s i}$ and $\beta \in L^{0}$, then $\varrho_{\alpha, \beta}[f]=\varrho_{\alpha, \beta}[\ln \mu, f]$ and $\lambda_{\alpha, \beta}[f]=\lambda_{\alpha, \beta}[\ln \mu, f]$. If, moreover, $\alpha\left(e^{x}\right) \in L_{s i}$ and $\alpha(x)=o(\beta(x))$ as $x \rightarrow+\infty$, then $\varrho_{\alpha, \beta}[\ln \mu, f]=\varrho_{\alpha, \beta}[v, f]$ and $\lambda_{\alpha, \beta}[\ln \mu, f]=\lambda_{\alpha, \beta}[\nu, f]$.

Proof. In view of the conditions $\alpha \in L_{s i}$ and $\beta \in L^{0}$ the equalities $\varrho_{\alpha, \beta}[f]=\varrho_{\alpha, \beta}[\ln \mu, f]$ and $\lambda_{\alpha, \beta}[f]=\lambda_{\alpha, \beta}[\ln \mu, f]$ follow from the estimates

$$
\mu(r, f) \leq M(r, f) \leq \sum_{k=0}^{\infty}\left|f_{k}\right| r^{k}=\sum_{k=0}^{\infty}\left|f_{k}\right|(2 r)^{k} 2^{-k} \leq 2 \mu(2 r, f) .
$$

It is well known [9, p. 13] that $\ln \mu(r, f)-\ln \mu(1, f)=\int_{1}^{r} \frac{v(t, f)}{t} d t$, whence

$$
\begin{equation*}
v(r / 2, f) \ln 2 \leq \int_{r / 2}^{r} \frac{v(t, f)}{t} d t \leq \ln \mu(r, f)-\ln \mu(1, f) \leq v(r, f) \ln r, \tag{7}
\end{equation*}
$$

and, therefore, in view of conditions $\alpha\left(e^{x}\right) \in L_{s i}, \beta \in L^{0}$ and $\alpha(x)=o(\beta(x))$ as $x \rightarrow+\infty$ we have

$$
\begin{aligned}
(1+o(1)) \frac{\alpha(v(r, f))}{\beta(\ln r)} & \leq\left(1+o(1) \frac{\alpha(\ln \mu(r, f))}{\beta(\ln r)} \leq \frac{\alpha(\exp \{\ln v(r, f)+\ln \ln r\})}{\beta(\ln r)}\right. \\
& \leq \frac{\alpha(\exp \{2 \max \{\ln v(r, f), \ln \ln r\}\})}{\beta(\ln r)} \\
& =\left(1+o(1) \frac{\alpha(\exp \{\max \{\ln v(r, f), \ln \ln r\}\})}{\beta(\ln r)}\right. \\
& =(1+o(1)) \frac{\max \{\alpha(v(r, f)), \alpha(\ln r)\}}{\beta(\ln r)} \leq(1+o(1)) \frac{\alpha(v(r, f))+\alpha(\ln r)}{\beta(\ln r)} \\
& =\left(1+o(1) \frac{\alpha(v(r, f))}{\beta(\ln r)}+o(1), \quad r \rightarrow+\infty,\right.
\end{aligned}
$$

and, thus, $\varrho_{\alpha, \beta}[\ln \mu, f]=\varrho_{\alpha, \beta}[v, f]$ and $\lambda_{\alpha, \beta}[\ln \mu, f]=\lambda_{\alpha, \beta}[v, f]$. The proof of Lemma 2 is completed.

Remark 2. From the condition $\frac{d \beta^{-1}(c \alpha(x))}{d \ln x}=O(1)$ as $x \rightarrow+\infty$ for each $c \in(0,+\infty)$ it follows that $\beta^{-1}(c \alpha(x)) \leq q x$ for each $c \in(0,+\infty)$ and some $q \in(0,+\infty)$, that is $\alpha(x) \leq \beta(q x) / c=$ $(1+o(1)) \beta(x) / c$ as $x \rightarrow+\infty$. Hence, in view of the arbitrariness of $c$ we obtain $\alpha(x)=o(\beta(x))$ as $x \rightarrow+\infty$.

The following proposition establishes a connection between the growth of entire function and its Gelfond-Leont'ev derivative.

Proposition 2. Let $\alpha \in L^{0}$ and $\beta \in L^{0}$. If condition (3) holds and $f$ is an entire function, then $\varrho_{\alpha, \beta}\left[D_{l}^{(n)} f\right]=\varrho_{\alpha, \beta}[f]$ and $\lambda_{\alpha, \beta}\left[D_{l}^{(n)} f\right]=\lambda_{\alpha, \beta}[f]$ for each $n \geq 1$.

Proof. It is enough to consider the case $n=1$. Condition (3) implies the existence of numbers $0<q_{1} \leq q_{2}<+\infty$ such that $q_{1}^{k} \leq l_{k} / l_{k+1} \leq q_{2}^{k}$ for all $k \geq 0$. Therefore,

$$
r \mu\left(r, D_{l}^{(1)} f\right)=\max \left\{\frac{l_{k}}{l_{k+1}}\left|f_{k+1}\right| r^{k+1}: k \geq 0\right\} \leq \frac{1}{q_{2}} \max \left\{\left|f_{k+1}\right|\left(q_{2} r\right)^{k+1}: k \geq 0\right\} \leq \frac{\mu\left(q_{2} r, f\right)}{q_{2}}
$$

and by analogy $r \mu\left(r, D_{l}^{(1)} f\right) \geq \mu\left(q_{1} r, f\right) / q_{1}$ for all $r$ enough large. Since $\ln r=o(\ln \mu(r, f))$ as $r \rightarrow+\infty$ for each entire transcendental function, hence we get the asymptotic inequalities

$$
(1+o(1)) \ln \mu\left(q_{1} r, f\right) \leq \ln \mu\left(r, D_{l}^{(1)} f\right) \leq(1+o(1)) \ln \mu\left(q_{2} r, f\right), \quad r \rightarrow+\infty
$$

whence by Proposition 1 the validity of Proposition 2 follows easy.
Corollary 1. Let $\alpha \in L_{s i}$ and $\beta \in L^{0}$. If $R[f]=+\infty, R[g]=1$ and (3) holds, then

$$
\lambda_{\alpha, \beta}\left[D_{l}^{(n)} f * D_{l}^{(n)} g\right]=\lambda_{\alpha, \beta}\left[D_{l}^{(n)}(f * g)\right]=\lambda_{\alpha, \beta}[f * g]
$$

and

$$
\varrho_{\alpha, \beta}\left[D_{l}^{(n)} f * D_{l}^{(n)} g\right]=\varrho_{\alpha, \beta}\left[D_{l}^{(n)}(f * g)\right]=\varrho_{\alpha, \beta}[f * g]
$$

for all $n \geq 1$.
Indeed, the equalities $\lambda_{\alpha, \beta}\left[D_{l}^{(n)}(f * g)\right]=\lambda_{\alpha, \beta}[f * g]$ and $\varrho_{\alpha, \beta}\left[D_{l}^{(n)}(f * g)\right]=\varrho_{\alpha, \beta}[f * g]$ follow directly from Proposition 2. To prove the equalities $\lambda\left[D_{l}^{(n)} f * D_{l}^{(n)} g\right]=\lambda\left[D_{l}^{(n)}(f * g)\right]$ and $\varrho\left[D_{l}^{(n)} f * D_{l}^{(n)} g\right]=\varrho\left[D_{l}^{(n)}(f * g)\right]$ it is enough to notice that, as at proof of Proposition 2, it is possible to get inequality

$$
q_{1}^{n} \mu\left(r, D_{l}^{(n)}(f * g)\right) \leq \mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right) \leq q_{2}^{n} \mu\left(r, D_{l}^{(n)}(f * g)\right)
$$

and use Lemma 2.

## 2 Relationship between the growth of the maximal terms of Hadamard composition of the derivatives and of the derivative of Hadamard composition

We start with two theorems close to the results cited in the introduction.
Theorem 1. Let $n \in \mathbb{Z}_{+}, \alpha\left(e^{x}\right) \in L_{s i}, \beta \in L^{0}$ and $\frac{d \beta^{-1}(c \alpha(x))}{d \ln x}=O(1)$ as $x \rightarrow+\infty$ for each $c \in(0,+\infty)$. Suppose that $R[f]=+\infty, R[g]=1$ and conditions (3) with $q>1$ and (6) hold. Then

$$
\begin{equation*}
\varlimsup_{r \rightarrow+\infty} \frac{1}{\beta(\ln r)} \alpha\left(\ln \frac{\mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}\right)=\varrho_{\alpha, \beta}[f] . \tag{8}
\end{equation*}
$$

If, moreover, $l_{k} l_{k+2} / l_{k+1}^{2} \nearrow 1,\left|f_{k} / f_{k+1}\right| \nearrow+\infty$ and $\left|g_{k} / g_{k+1}\right| \nearrow 1$ as $k_{0} \leq k \rightarrow \infty$, then

$$
\begin{equation*}
\varliminf_{r \rightarrow+\infty} \frac{1}{\beta(\ln r)} \alpha\left(\ln \frac{\mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}\right)=\lambda_{\alpha, \beta}[f] . \tag{9}
\end{equation*}
$$

Proof. In [6], the following estimates are proved

$$
\begin{equation*}
\frac{l_{v\left(r, D_{l}^{(n)}(f * g)\right)}}{l_{v\left(r, D_{l}^{(n)}(f * g)\right)+n} \leq \frac{\mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)} \leq \frac{l_{v\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}}{l_{v\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)+n}} . . . ~} \tag{10}
\end{equation*}
$$

Condition (3) with $q>1$ implies the existence of numbers $1<q_{1} \leq q_{2}<+\infty$ such that $q_{1}^{k n} \leq l_{k} / l_{k+n} \leq q_{2}^{k n}$ for all $k \geq k_{0}$. Therefore, from (10) we get

$$
\begin{equation*}

the proof of this theorem is the same as the proof of Theorem 3.

## 3 Addition

Choosing $\alpha(x)=\ln ^{+} x$ and $\beta(x)=x^{+}$, from the definitions of $\varrho_{\alpha, \beta}[f]$ and $\lambda_{\alpha, \beta}[f]$ for entire function (1) we get the definitions of the order $\varrho[f]=\varlimsup_{r \rightarrow+\infty} \frac{\ln \ln M(r, f)}{\ln r}$ and the lower order $\lambda[f]=\frac{\lim }{r+\infty} \frac{\ln \ln M(r, f)}{\ln r}$. The selected functions $\alpha$ and $\beta$ satisfy all the conditions of Theorems 1-4 except of the condition $\alpha\left(e^{x}\right) \in L_{s i}$ that arose as a result of the applying Lemma 2. But from (7) it follows, that $\varrho[v, f]=\varrho[\ln \mu, f], \lambda[v, f]=\lambda[\ln \mu, f]$ and, thus, $\varrho[v, f]=\varrho[f], \lambda[v, f]=$ $\lambda[f]$. Therefore, from (11) we get

$$
\begin{aligned}
& \varrho\left[D_{l}^{(n)}(f * g)\right] \leq \varlimsup_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \ln \frac{\mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)} \leq \varrho\left[D_{l}^{(n)} f * D_{l}^{(n)} g\right], \\
& \lambda\left[D_{l}^{(n)}(f * g)\right] \leq \lim _{r \rightarrow+\infty} \frac{1}{\ln r} \ln \ln \frac{\mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)} \leq \lambda\left[D_{l}^{(n)} f * D_{l}^{(n)} g\right]
\end{aligned}
$$

and repeating the proof of Theorem 1 we arrive at the following statement.
Proposition 3. Let $n \in \mathbb{Z}_{+}, R[f]=+\infty, R[g]=1$ and conditions (6) and (3) with $q>1$ hold. Then

$$
\varlimsup_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \ln \frac{\mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=\varrho[f]
$$

and if, moreover, $l_{k} l_{k+2} / l_{k+1}^{2} \nearrow 1,\left|f_{k} / f_{k+1}\right| \nearrow+\infty$ and $\left|g_{k} / g_{k+1}\right| \nearrow 1$ as $k_{0} \leq k \rightarrow \infty$, then

$$
\varliminf_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \ln \frac{\mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=\lambda[f] .
$$

If (15) holds, then from (19) we get

$$
\begin{aligned}
& (2 m-n) \varrho\left[D_{l}^{(n)}(f * g)\right] \leq \varlimsup_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \frac{r^{m-n} \mu\left(r, D_{l}^{(m)} f * D_{l}^{(m)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)} \leq(2 m-n) \varrho\left[D_{l}^{(m)}(f * g)\right], \\
& (2 m-n) \lambda\left[D_{l}^{(n)}(f * g)\right] \leq \varliminf_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \frac{r^{m-n} \mu\left(r, D_{l}^{(m)} f * D_{l}^{(m)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)} \leq(2 m-n) \lambda\left[D_{l}^{(m)}(f * g)\right]
\end{aligned}
$$

and repeating the proof of Theorem 2 we arrive at the following statement.
Proposition 4. Let $n \in \mathbb{Z}_{+}, m \in \mathbb{N}, m>n, R[f]=+\infty, R[g]=1$ and conditions (15) and (6) hold. Then

$$
\varlimsup_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \frac{r^{m-n} \mu\left(r, D_{l}^{(m)} f * D_{l}^{(m)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=(2 m-n) \varrho[f] .
$$

If, moreover, $l_{k} l_{k+2} / l_{k+1}^{2} \nearrow 1,\left|f_{k} / f_{k+1}\right| \nearrow+\infty$ and $\left|g_{k} / g_{k+1}\right| \nearrow 1$ as $k_{0} \leq k \rightarrow \infty$, then

$$
\varliminf_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \frac{r^{m-n} \mu\left(r, D_{l}^{(m)} f * D_{l}^{(m)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=(2 m-n) \lambda[f] .
$$

Using (27) and (28) similarly we prove the following statement.
Proposition 5. Let $n \in \mathbb{Z}_{+}, m \in \mathbb{Z}_{+}, m>n, R[f]=+\infty, R[g]=1$ and condition (6) holds. If (3) with $q>1$ holds, then

$$
\varlimsup_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \ln \frac{r^{m-n} \mu\left(r, D_{l}^{(m)}(f * g)\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=\varrho[f]
$$

and if, moreover, $\left|f_{k} / f_{k+1}\right| \nearrow+\infty$ and $\left|g_{k} / g_{k+1}\right| \nearrow 1$ as $k_{0} \leq k \rightarrow \infty$, then

$$
\underline{l i m}_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \ln \frac{r^{m-n} \mu\left(r, D_{l}^{(m)}(f * g)\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=\lambda[f] .
$$

If (15) holds, then

$$
\varlimsup_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \frac{r^{m-n} \mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=(m-n) \varrho[f],
$$

and if, moreover, $\left|f_{k} / f_{k+1}\right| \nearrow+\infty$ and $\left|g_{k} / g_{k+1}\right| \nearrow 1$ as $k_{0} \leq k \rightarrow \infty$, then

$$
\lim _{r \rightarrow+\infty} \frac{1}{\ln r} \ln \frac{r^{m-n} \mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=(m-n) \lambda[f] .
$$

Finally, the following statement also is true.
Proposition 6. Let $n \in \mathbb{Z}_{+}, m \in \mathbb{N}, m>n, R[f]=+\infty, R[g]=1$ and condition (6) holds. If (3) with $q>1$ holds, then

$$
\varlimsup_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \ln \frac{\mu\left(r, D_{l}^{(m)}(f * g)\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=\varrho[f]
$$

and if, moreover, $\left|f_{k} / f_{k+1}\right| \nearrow+\infty$ and $\left|g_{k} / g_{k+1}\right| \nearrow 1$ as $k_{0} \leq k \rightarrow \infty$, then

$$
\varliminf_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \ln \frac{\mu\left(r, D_{l}^{(m)}(f * g)\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=\lambda[f]
$$

If (15) holds, then

$$
\varlimsup_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \frac{r^{m-n} \mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=2(m-n) \varrho[f]
$$

and if, moreover, $\left|f_{k} / f_{k+1}\right| \nearrow+\infty$ and $\left|g_{k} / g_{k+1}\right| \nearrow 1$ as $k_{0} \leq k \rightarrow \infty$, then

$$
\underline{l}_{r \rightarrow+\infty} \frac{1}{\ln r} \ln \frac{r^{m-n} \mu\left(r, D_{l}^{(n)} f * D_{l}^{(n)} g\right)}{\mu\left(r, D_{l}^{(n)}(f * g)\right)}=2(m-n) \lambda[f] .
$$

Мулява О.М., Шеремета М.М. Про адамарову композицію похідних Гельфонда-Леонтьєва цілих та аналітичних в одиничному крузі функиій // Карпатські матем. публ. - 2021. — Т.13, №1. — С. 98-109.

Для цілої функції і аналітичної в одиничному крузі функції у термінах узагальнених порядків досліджено зростання адамарової композиції їх похідних Гельфонда-Леонтьєва.
